Under this joint privacy notice (hereinafter the “Notice”), we inform you how we process your personal data on our EEX Group Leadership Offsite 2022 (hereinafter also “Event”). Your personal data means any information relating to you (hereinafter the “Personal Data”), such as name or contact details.

We pay special attention on the processing of Personal Data in accordance with the General Data Protection Regulation EU 2016/679 (“GDPR”) and applicable national data protection laws.

### 2 Purpose, Categories of Personal Data, Legal Basis and Retention

Your information is used to allow your attendance at the event. We collect Personal Data when you voluntarily provide it, such as when you register for the event, or participate as presenter in the event.

#### 2.1 Categories of your Personal Data and purposes of our processing

We process name, company and e-mail address for your event registration. If you are a presenter in the event, we are recording your appearance.

#### 2.2 Legal basis for our processing of your Personal Data

As your participation is completely voluntary, the relevant legal basis for processing your personal data is your consent in accordance with Article 6 Paragraph 1 lit. a in connection with Article 7 GDPR.

#### 2.3 Do you have to provide your Personal Data to us?

The provision of your Personal Data is necessary to allow the livestreaming during of the event. This means that you are obliged to provide your Personal Data to us when taking part in the MS Teams Sessions.

#### 2.4 Do we make automated decisions on you?

We do not make any automated decisions solely on automatic processing, including profiling, which produces legal effects concerning you or similarly significantly affects you.

## **2.5 Retention periods**

Personal data collected to allow you the access to the livestreaming event will be deleted after the event. A recorded version of this live event will be available and will be deleted one month after the end of this event. Any personal data related with this recording will be deleted at this time as well.

## **3 Transfer of Personal Data to Third Parties**

We will not transfer your Personal Data to third parties except such transfer is permitted by law or you have explicitly consented to the transfer.

## **4 Your Rights**

Under applicable data protection laws, you have rights

- of access to, rectification of, and/or erasure of your Personal Data;

- to the extent Our processing of your Personal Data is based on your consent, you also have the right to withdraw your consent, without affecting the lawfulness of Our processing based on your consent before its withdrawal.
